


CARA Hub: Powered by AWS

Powered by the flexibility of AWS hosting, a private or multi-tenant cloud (depending on your security and compliance requirements) can be provided within a matter of days, with multiple archival storage options to create the most cost-effective solution for you.

Example Record Management Lifecycle







Customisable Retention Scheme

Create custom file plans or choose one of our preconfigured options. These define retention periods, disposition rules, folder locations (if appropriate – they can also be driven by document type). Assigning a record to a file plan will bring all the associated documents under the control of these rules.



Compliant Archival & Disposition

Proper destruction or purging of records at the end of the retention periods is critical for security and compliance. Users can define multiple purging categories, and specify the decomissioning options such as: remove content only and keep metadata, move to archive, or completely destroy.







Secure e-Records

Secure electronic records based on the file plans, attaching multiple documents to a single record if required. The documents can be stored in the CARA Hub or an external system, but are prevented from being modified or deleted for the period of the defined retention.



Paper File Management

Create a record of paper files, which can include definition of location (configurable, e.g. building / room / cabinet numbers) as well as geo-tagging which allows for a map-based records search. Bar codes additionally allow association of paper records with the electronic record.



Plug & Play

The CARA Hub is pre-configured, requiring only a minor adaption and configuration to your enterprise's lifecycle, process, and taxanomy. The CARA Hub comes as standard with a 100% REST API to connect to any systems or solution, allowing for the record lifecycle to begin within a different system if required.
